

Financial Report

We will have to submit the Financial Report at the end beginning of 2018

All documents required in the Participant Portal have to be prepared well in advance. The list is not yet available

Your local administration have to provide all relevant information to the coordinator, which is in charge of the submission

In particular, "Researchers' Declarations" containing all 2016-2017 secondments have to be updated and corrected: this information cannot be modified in case of errors after the Financial Report

Most of the beneficiaries have "Researchers' Declarations" updated or almost updated, but there are special cases to be fixed as soon as possible

Financial Report: important rules

What is important to keep in mind:

- 1. As a general rule, it is not possible to include new secondment for the period 2016-2017 after the FR. This means that if some travels are not uploaded on PP before the FR, it will not be possible to do it later on
- 2. We will not receive the whole residual amount of money, i.e. 45% of the overall budget.
 - Each institution will receive just the money equivalent to the secondment performed in the first two years of the project
